1. Introduction

• ANM School, Rural Health Training Centre, Najafgarh

Rural Health Training Centre, Najafgarh is a pioneer institute for nursing education in Delhi offering Auxiliary Nurse Midwifery (A.N.M.) Diploma Course. It is controlled by Directorate General of Health Services (DGHS) and academically affiliated to Indian Nursing Council (INC) and Delhi Nursing Council (DNC). The primary objective of the Institute is to provide and promote education in the field of nursing.

The ANM School, RHTC established in 1985 with 20 & 10 students in take on alternate years as MPWF (Multi-Purpose Worker Female) recognized with Punjab Nursing Council, managed in two rooms & one Auditorium & duration of course was two years including six months internship training. In 1991 above course was renamed as ANM 10+2 (vocational) courses under CBSE & India Nursing Council with 20 student's capacity every year.

From 2012 onwards Delhi Nursing Council started two years Diploma in ANM, after 10+2. Selection for admission in ANM occurs through Combined Competitive Examination along with Lady reading Health School, Bara Hindu Rao, Delhi.

• Lady Reading Health School, Bara Hindu Rao

The First training institution for Health Visitors was started in Delhi in 1918 with 12 students under the auspices of the Countess of Dufferin Fund through the efforts mainly of Dr. M. I. Balfour, the then Secretary. Subsequently, the School became one of the centers of activity of the Lady Chelmsford League when the Dufferin fund was absorbed by the former. The Government of India sanctioned an annual grant of Rs.6, 000/-. In 1925, Lady Reading, wife of the Viceroy of the time, presented about one lakh of rupees from funds at her disposal towards the provision of a suitable building

together with a model Welfare Centre for the practical training of students. Thus, the School was named after the donor.

Lady Reading Health School (LRHS), Delhi is considered as one of the pioneer institutions. In 1952 the Government of India took over the school and attached Ram Chand Lohia MCH Centre. Initially total capacity of the school was 24 Health Visitors trainees from all over India and neighboring countries. Duration of the course was one and half years for matriculates who were qualified midwives, which was replaced by two and half years integrated course for health visitor in 1954. Since then, LRHS is providing training to different categories of Nursing candidates specialization in community Health Nursing.

In the year 1985 ANM Training started with intake capacity of 40 every year. The duration of the course was 2 Years. In 1990 ANM Training converted into ANM (vocational) and duration of the course changed from 2 years to 1.5 years and minimum qualification for entrance was matriculation/10th Pass. Examination was conducted by CBSE and passed candidate were given 10+2 certificate by CBSE and ANM certificate by Punjab nursing council and then by Delhi Nursing Council. In the year 2006 the school came direct under Ministry of Health and Family welfare (MOHFW).

In the year 2012 the ANM course came under DNC (Delhi Nursing Council) and now the examining and certifying body is DNC, Intake capacity of ANM students enhanced from 20 to 40 in the year 2008. The eligibility criteria also changed from 10th pass to 12th pass. Admission process of ANM course is through Combined Entrance Examination for Lady Reading Health School and Rural Health Training Centre, Najafgarh.

2. Aim of the Schools

The purpose of the ANM course is to prepare an ANM to function at the community level/village with specific skills to fulfill the health needs of the community. She will be an active link between the community and the health care system.

To make a system of nursing education that fits in with the changing educational patterns of the country to meet the health needs of the society.

3. Course Offered

4. Overview of the Course

Auxiliary Nurse Midwifery (A.N.M.)

Duration of the Course: Two Years

ANM Nursing is a two-year regular diploma course that deals with primarily deals with the health care sector. The course provides knowledge about maternal child health and nutrition education, efforts for maintain environmental sanitation, immunization for the control of communicable diseases, treatment of minor injuries, and first aid in emergencies and disaster.

Area of study includes

- Mother & Child Health
- Community Health
- Midwifery
- Health Promotion
- Primary Health Care
- Nutrition etc.

Examinations are held annually at the end of each academic year as per DNC calendar. There are total 6 theory papers and 4 viva cum practical papers. Internal assessment is done continuously throughout the academic session by conducting term test, assignments, and field postings.

Attendance requirements: 80% attendance in theory and 100% attendance in practical required for appearing in final council examination conducted by Delhi Nursing Council.

Note: Medium of instruction is Hindi and English both.

5. Auxiliary Nurse Midwifery (A.N.M.) (2024-25)

1. Eligibility criteria

- **1.1.** Candidate must have passed senior secondary (10+2) of any stream, school certification examination from the school located in Delhi region affiliated to CBSE/ICSE or examination conducted by National Institute of Open Schooling (NIOS) enrolled from NCT of Delhi only.
- **1.2.** Only female candidates are eligible for the course.
- **1.3.** Candidate must have residence proof of Delhi or having Domicile since 2019 onwards
- **1.4.** Candidates appearing in class 12th examination 2024 are also eligible for Combined Entrance Exam 2024.
- **1.5.** The minimum age for admission shall be 17 years on or before 31st December, 2024 and the maximum age for admission shall be 30 years for Unreserved & EWSs category candidates. Relaxation in upper age limit for OBC/SC/ST/PwD candidates as per government rules, i.e. up to 3 years relaxation for OBC and 5 years relaxation for SC/ST/PwD.
- **1.6.** The OBC/SC/ST/PwD Certificate should be as per "Central Government Performa" and not as per state govt. Performa.
- **1.7.** In case of PwD candidates, the percentage of disability of locomotors to be maximum of the tune of 40% to 50% of the lower extremity. Other conditions regarding disability will be strictly as per Indian Nursing Council Resolution dated 19th April, 2012.
- **1.8.** Reservation of seats for Other Backward Class/Schedule Tribe/Schedule Caste/Economically Weaker Sections and Person with Disability will be as per Government of India guidelines applicable for admission in under Diploma Courses.

2. Admission (Selection) Criteria

- **2.1.** The Admission/Selection of candidates for admission to A.N.M. course will be made on the basis of merit of Combined Entrance Exam 2024.
- 2.2. Tie Breaker Rules
 - a) Candidate with higher marks in class 12th examination will be given higher Rank.
 - **b**) If candidates receive same marks in class 12th examination, then candidate with higher age will get higher Rank.
 - c) If above two conditions also tie then Higher Rank will be given in alphabetical order.

3. Combined Entrance Exam 2024

- **3.1.** Combines Entrance Exam 2024 will be held on 07th July, 2024 (Sunday) at 10:00 AM at centre mentioned in the admit card. The test will be of 2 hours in duration and shall contain CBT objective/MCQs type questions. The exam will be based on 10 level of Science, Hindi & English grammar, and General Knowledge.
- **3.2.** All Candidates are required to report one hour before the commencement of the exam.
- **3.3.** No negative marking will be there.

4. Seats Allocation

Total Number of Seats are 88 (44 seats for RHTC & 44 seats for LRHS).

5. <u>Reserved Categories</u>

- **5.1.** Other Backward Classes (OBC) candidates: 27% seats (22) are reserved for other backward classes (OBC) candidates (as per central OBC list). Certificate must be in Non-Creamy Layer (NCL) central Govt. Performa.
- **5.2.** Schedule Caste (SC) candidates: 15% seats (12) are reserved for schedule caste (SC) candidates. Subject to production of valid certificate.
- **5.3.** Schedule Tribe (ST) candidates: 7.5% seats (06) are reserved for schedule tribe (ST) candidates. Subject to production of valid certificate.
- **5.4. Person with Disability (PwD) candidates:** There is provision of 5% seats (4) for Person with Disability. Candidate has to fulfill/satisfy the norms stipulated by the Indian Nursing Council.
- **5.5. Economically Weaker Sections (EWSs) candidates:** 10% of total no. of seats is reserved for the economically weaker sections (EWSs) as per the guidelines of Govt. of India. For format of Economically Weaker Section Certificate. (**Refer to Annexure- I page no.21**)
- 6. Last date of Online submission of application is 22nd June, 2024 (up to 12:00 AM midnight).
- **6.1.** Online Applications for session 2024-26 are invited from 19th May,2024 on RHTC & LRHS official website www.rhtcnajafgarh.in & www.ladyreadinghealthschool.com .
- **6.2.** Mode of payment will be online through SB Collect.
- 6.3. Fees once paid will not be refunded in any circumstance.

- **6.4.** The admission to the course shall be made purely on the basis of merits obtained in Combined Entrance Exam 2024.
- **6.5.** Result of Combined Entrance Exam 2024 will be displayed on the website (**www.rhtcnajafgarh.in** & **www.ladyreadinghealthschool.com**) & notice board of the RHTC & LRHS.
- 6.6. All Admission are provisional subject to verification of original documents and medical examination conducted by RHTC & LRHS authority.
- 6.7. Admission taken on wrong information shall be summarily cancelled without refund of fees.
- **6.8.** In case of false records/documents are detected, the student will be debarred from attending any course in the ANM School, Collages or any other course for next five years and in addition, a criminal case under relevant section of IPC (viz. 470, 461, 474) etc. will be instituted against candidate to subject to requisite criminal proceeding.

7. Instruction for Scheduled Caste (SC)/Scheduled Tribes (ST)/Other Backward Classes (OBC)/Economically Weaker Sections (EWS)/Person with Disability (PwD) candidates

- **7.1.** A Scheduled Caste/Scheduled Tribe /OBC/EWSs candidate while applying online for the course will be required to upload a copy of certificate to effect that candidate belongs to Scheduled Caste/Scheduled Tribes/OBC (non-creamy layer as per central OBC list)/EWSs issued in the same financial year from the competent authority, as listed below.
- 7.2. District Magistrate/Additional District Magistrate/Collector/Deputy Commissioner/Deputy Collector 1st class stipendiary Magistrate/Sub-Divisional Magistrate/Taluka Magistrate/ Executive Magistrate/Extra Assistant Commissioner.
- **7.3.** District Presidency Magistrate/Additional Chief Presidency Magistrate/Presidency Magistrate.
- 7.4. Revenue Officer not below the rank of Tehsildar.
- **7.5.** Sub-Divisional Officer of the area where the candidate and her family normally resides.
- **7.6.** Person with Disability must produce Certificate of disability from a Medical Board recognized by Central Govt. of India.

8. <u>Common Mistakes made by candidates which resulting in rejection of application</u>

- **8.1.** Variation in names spelling as recorded in application, 10th Certificate/Mark sheet or equivalent certificate
- **8.2.** Uploading Photograph & signature in wrong format.
- **8.3.** Not uploading desired documents.
- **8.4.** Uploading blurred/ not cleared images of documents.

Note: Any false information/false documents detected in the requisite application will result in cancellation of the candidature of the candidate at any stage of selection/Admission and /or during the course of study.

9. Directions to the candidates for Combined Entrance Exam 2024.

- 9.1. Computer Based Test.
- **9.2.** The examination hall shall be opened one hour before the commencement of the examination.
- **9.3.** No candidate will be allowed to enter the examination hall after the commencement of the examination.
- 9.4. Each candidate must show, on demand her Admit Card.
- **9.5.** No candidate is permitted to leave the examination hall before the expiry of the allotted time for the Combined entrance Exam.
- **9.6.** A seat with Roll No. will be allotted to each candidate; candidates must find out and occupy their allotted seats.
- **9.7.** Candidates will be required to sign. their names on attendance sheet and give their left thumb impression.
- **9.8.** No. Tea /Coffee, cold Drinks or snacks are allowed to be taken inside of the examination hall during examination hours.
- **9.9.** A candidate found guilty of the use of dishonest or unfair means of disorderly conduct in the examination shall be disqualified and be debarred from appearing at any future selection test of the School, collage or any other authorized body.
- **9.10.** Mobile phones/calculator/electronic devices/ornaments/bags/water bottle etc. is not allowed inside the examination hall.

11. Counseling, Fee and other Charges

11.1. Counselling: Counseling will be held in 3 parts. (a) First Counseling will only for the candidates who are provisionally selected in UR category. (b) Second Counseling only for the candidates who are provisionally selected in OBC category. (c) Third Counseling only for the candidates who are provisionally selected in SC/ST/EWSs/PwD categories.

Dates for Counseling: (a) For UR Category – 17th July, 2024 (b) For OBC Category – 18th July, 2024 (c) For SC/ST/EWS/PwD – 19th July, 2024

Option to choose Institution: (I) On Merit Basis

(II) On Choice of candidate

(III) On Availability of seats in the Institution

- A waiting Counseling may be conducted if all the seats are not filled in counseling dates mentioned above.
- All the Original Documents i.e. 10th Marks Sheet & Certificate, 12th Marks Sheet & Certificate, Aadhar Card or Domicile (if available), Caste certificate and Medical reports as desired in counseling letter must be shown at the time of counseling.
- Non production of original documents at the time of counseling attracts cancellation of candidature.
- All original document of candidate will be taken into custody of RHTC & LRHS authority for verification. And will return to candidates after verification report received from the concerned Examination Body or other respective board(s)/competent authority.
- If seat is not filling in the counseling, then it will be given to the candidate who is in waiting list at the time of waiting/panel counseling.

11.2. Fee & Other Charges:

11.3. Return of Security Money: If a candidate chooses to withdraw from the course (in the middle of session) in which candidate is enrolled, security money deposited by the

candidate will be refunded to candidate within 30 days from the receiving a written application by candidate in this regard after deducting 5% of processing charge.

12.2. Documents required at the time of counseling (must be produce in Original along with self attested copies)

- Class 10th Marks Sheet & Certificate
- Class 12th Marks Sheet & Certificate
- SC/ST/OBC/PwD/EWSs certificate as per Govt. of India format.
- Latest Color Photograph (with name, date & white background).
- Character Certificate (not more than 6 months old)
- Medical reports as required in counseling letter.

Note: Original documents will take into custody for verification and will return after verification to candidates.

13. Medical Examination

- **13.1.** A Medical Test will conduct at Rural Health Training Centre, Najafgarh to check the medical fitness of the candidates as per norms of the Indian Nursing Council in supervision of two doctors authorized by the Committee.
- **13.2.** If candidate found unfit in medical test conducted by Rural Health Training Centre, Najafgarh her candidature will be cancelled with immediate effect.
- **13.3.** Candidate must produce X-Ray Chest PA view with report and Eye Fitness Certificate at the time of Medical Test as required in counseling letter
- **13.4.** For PwD candidates whose disability not mentioned in Indian Nursing Council norms will refer to Medical Board of a Higher Institution to check the eligibility & fitness of candidate for ANM course. After Medical Board gives fitness certificate to candidate only then they will get admission into course.

Note: Until Fitness or Unfit certificate receives from the Medical Board, admission of the candidate will be on standby and no other candidate will be given admission on their seat.

14. <u>Hostel is currently under maintenance at RHTC & LRHS.</u>

15. <u>Maintenance of Discipline among students of the Institutions.</u>

- **15.1.** The following shall amount to acts of gross indiscipline.
 - a) Physical assault or threat to use physical force, against any member of the teaching and non-teaching staff of the institutions and against any students within in the *institution*.
 - **b**) Carrying of, use of, or threat of use of any weapons.
 - c) Any violation of the provisions of the Civil Rights Protection Act, 1976.
 - **d**) Violation of the status, dignity and honour of students belonging to the scheduled castes and scheduled tribes.
 - e) Any practice whether verbal or otherwise derogatory of women.
 - f) Any attempt at bribing or corruption in any manner.
 - g) Willful destruction of institution property.
 - **h**) Creating ill-will of intolerance on religious or communal grounds.
 - i) Causing disruption in any manner of the academic functioning of the university system.
 - **j**) Ragging in any manner.

- **15.2.** Maintenance of Discipline and taking such action in interest of maintaining discipline as may seems appropriate, the head of the Institute may exercise his/her powers aforesaid order or direct that any student or students;
 - a) Be expelled; OR
 - **b**) Be, for a stated period rusticated; OR
 - c) Be not for a stated period, admitted to a course or courses of study in collage, Department or institution ; OR
 - d) Be fined with a sum of rupees that may be specified; OR
 - e) Be debarred from taking a Institution/Collage or Departmental examination or examinations for one or more years; OR
 - **f**) That the result of the student or students concerned in the examination or examinations in which student or students have appeared be cancelled.

16. <u>Ordinance XV-C</u> <u>Prohibition of and Punishment for Ragging</u>

- **a**) Ragging in any form is strictly prohibited, within the premises of the Institutions.
- **b**) Any individual or collective act or practice or ragging constitutes gross indiscipline and shall be dealt with under this ordinance. Ragging for the purpose of this ordinance, ordinarily means any act conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and includes individual or collective acts or practice which:
 - Involve physical assault or threat or use of physical force.
 - Violate the status, dignity and honour of female.
 - Violate the status, dignity and honour of the students belonging to the scheduled castes and scheduled tribes.
 - Expose students to ridicule on contempt and affect their self-esteem.
 - Entail verbal abuse and aggression, indecent gestures and obscne behavior.
 - c) The principal of the institution, the head of the department or institution, the authorities of institution, Hostel or Halls or residence shall take immediate action on any information of the occurrence of ragging.
 - **d**) The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of ragging incident.
 - e) The HOD/HOI may in other cases of the ragging order or direct that any student or students be expelled or not to be stated, period admitted to a course of study and results of the student or students concerned in the examination or examinations in which they appeared be cancelled.

- **f)** In case where students who have obtained diploma of the institute are found guilty under this ordinance, appropriate action will be taken or withdrawal of diploma conferred by the Institution.
- **g**) For the purpose of this ordinance, abetment of ragging will also be amount to ragging.

<u>UGC Regulations on curbing the menace of ragging higher</u> <u>educational institution under section 26(1)(G) of the University Grants</u> <u>Commision Act, 1956</u>

Following measures are taken by the institution to prevent ragging.

- a) Written notice expressing that ragging is totally prohibited in the institution.
- **b**) Those who found guilty of ragging/abetting ragging, actively or passively or being part of a conspiracy to promote ragging is liable to be punished in accordance with these regulations as well as under the provisions of any penal law for the time being in force.
